- CALL TO ORDER Chair Martin called the meeting to order at 3:00 p.m. Chair Martin advanced to Agenda No. 4a Consideration of Resolution No. 2022-08-Resolution to Implement Teleconference Requirement During a Proclaimed State of Emergency. By a motion of Director Nelsen, seconded by Director Bixler approved and unanimously approved by all Directors present, Resolution 2022-08 was approved.

 - i. Emergency Ordinance to Establish an Extraction Limitation for the Mid-Kaweah Groundwater Sustainability Agency Service Area Update – Mr. Fukuda gave the update noting that the program was achieving reductions in evapotranspiration and that due to the ongoing conditions he recommended that the Board leave the Emergency Ordinance in place. The Board concurred with Mr. Fukuda and advised him to leave the Emergency Ordinance in place pending any recommendations that may be forthcoming form the MKGSA Advisory Committee.
 - *ii.* Consider Task Order No. 9 with Montgomery & Associates for Miscellaneous Technical Support – Mr. Fukuda gave the review. By a motion of Director Bixler and seconded by Director Mederos the Board of Directors approved Task Order No. 9 by the following roll-call vote: Director Collins – Yes Director Nelsen – Yes Director Stroman – Yes Director Martin – Yes
